- A. This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of supporting the GPP project to upgrade Building 62 3<sup>rd</sup> floor general purpose laboratories and infrastructure to mission readiness.
- B. Accordingly, pursuant to Section I Contract Clause I.104– DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$2,900,000.00 consisting of operating funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$2,473,404,266.11 to \$2,476,304,266.11.
- C. The specific Contractor Recovery Act Statement of Work, Milestones, Outcomes and Measures, and Deliverables funded by this modification are identified in the following referenced Work Authorization:
