- A. This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of supporting the update, upgrade, or capability expansion of the Molecular Foundry as follows:

\$1,961,000 - Multimode Surface Analysis System
\$1,455,000 - Robotic Bipolymer Purification and Analysis System
\$1,300,000 - 18 TFlop Mid-Range Computing Cluster

Accordingly, pursuant to Section I Contract Clause I.104– DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$5,908,000.00 consisting of operating funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$2,794,121,841.50 to \$2,800,029,841.50.
