A. This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of supporting the following updates/upgrades for the Advanced Light Source:

1. \$3,300,000 AIP funds for acquisition of sextupoles magnets to increase the Advanced Light Source brightness.
2. \$2,000,000 equipment funds for acquisition of detectors for the beamlines.
3. \$2,000,000 equipment funds for EPU for the Slice beamline.
4. \$1,500,000 equipment funds for high-field vector magnet for novel soft x-ray dichroism experiments.

Accordingly, pursuant to Section I Contract Clause I.104– DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$8,800,000.00 consisting of \$5,500,000 operating funds and \$3,300,000 in construction funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$2,808,829,841.50 to \$2,817,629,841.50.
