This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of supporting the Joint Genome Institute by acquiring new computing infrastructure; purchase of third-generation sequencing hardware; and preliminary sequencing of important plant reference genomes.

Accordingly, pursuant to Section I Contract Clause I.104– DEAR 970.5232-4 entitled “Obligation of Funds,” funds in the amount of \$10,498,000.00 consisting of operating funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$2,833,078,841.50 to \$2,843,576,841.50.
