This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of supporting the revitalization of the workforce of the National Nuclear Data Center. This is additional funding to further the work funded under modification A137 and converts a part-time position to full-time to address staff shortages of the U.S. Nuclear Data Program.

Accordingly, pursuant to Section I Contract Clause I.104– DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$95,000.00 consisting of operating funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$2,876,211,618.01 to \$2,876,306,618.01.
