Accordingly, pursuant to Section I Contract Clause I.104– DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$61,778,000.00 consisting of operating funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$2, 877,181,618.01 to \$2,938,959,618.01.
