


This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of supporting the Joint Genome Institute by acquiring new computing infrastructure; purchase of third generation sequencing hardware; and preliminary sequencing of important plant reference genomes.

Accordingly, pursuant to Section I Contract Clause I.104– DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$2,624,000.00 consisting of operations funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$2,943,831,980.01 to \$2,946,455,980.01.

- B. The specific Contractor Recovery Act Statement of Work, Milestones, Outcomes and Measures, and Deliverables funded by this modification are identified in the following referenced Work Authorization:
