- A. This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of enabling the Lawrence Berkeley National Laboratory (LBNL) to provide technical assistance to enhance and accelerate FEMP service functions to the Federal government. LBNL will provide services in the following areas: Initial and/or feasibility of particular technology; project prioritization; strategic energy planning and benchmarking; technical reviews of designs and proposals; energy audit training; green building technical support, federal vehicle fleet technical support and additional actions called out in the work authorization cited below.

Accordingly, pursuant to Section I Contract Clause I.104- DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$600,000.00 consisting of operations funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$2,946,643,980.01 to \$2,947,243,980.01.

- B. The specific Contractor Recovery Act Statement of Work, Milestones, Outcomes and Measures, and Deliverables funded by this modification are identified in the following referenced Work Authorization:
