This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of providing \$13,900,000 in construction funding for the Seismic Safety of General Purpose Buildings, Phase II project (09-SC-72) for activities approved under associated critical decisions.
- B. Accordingly, pursuant to Section I Contract Clause I.104– DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$13,900,000.00 consisting of construction funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$3,001,998,061.08 to \$3,015,898,061.08.
