- A. This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of providing \$564,600.00 in operations funding for project # 20685 – EGS R&D (2004190). These funds are to be distributed to Agreement #19973-Integrated Approach to Use Natural Chemical and Isotopic Tracers to Estimate Fracture Spacing and Surface Area in EGS Systems, in accordance with field work proposal #ESD09-011. Lawrence Berkeley National Laboratory will conduct a series of laboratory experiments to quantify the reactivity of a suite of natural chemical and isotopic tracers as a function of fluid chemistry, temperature, surface area, and time, and incorporate the measured solute reactivities into a tracer analysis model.
- B. Accordingly, pursuant to Section I Contract Clause I.104– DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$564,600.00 consisting of operations funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$3,040,574,757.08 to \$3,041,139,357.08.
