This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of providing \$110,000.00 in operations funding for project # 20454 – Enhance and Accelerate FEMP Service Functions to the Federal Government. These funds are to be distributed to Agreement #19209-LBNL-ESPC- Call for FEMP Technical Services, in accordance with AOP# 2004160. Lawrence Berkeley National Laboratory will provide Energy Savings Performance Contract technical assistance and project management support activities in accordance with the identified work authorization. None of the funds provided are approved for any type of support service subcontracting.
- B. Accordingly, pursuant to Section I Contract Clause I.104– DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$110,000.00 consisting of operations funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$3,041,139,357.08 to \$3,041,249,357.08.
