This modification is issued to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the purpose of providing \$20,000.00 in operations funding for the Laboratory to support the Federal Energy Management Program by providing technical assistance to specific agencies selected under the FY09 call for Recovery Act funded projects. Projects assigned are to support Federal agencies wishing to consider the use of power purchase agreements to finance the purchase of electricity from renewable resources. Funding provided under this work authorization is not approved for obligation of any type of support service contract either as a prime or subcontract award.
- B. Accordingly, pursuant to Section I Contract Clause I.104- DEAR 970.5232-4 entitled "Obligation of Funds," funds in the amount of \$20,000.00 consisting of operations funds are hereby obligated in support of Recovery Act activities. The total amount of funds obligated under this contract since its inception is increased from \$3,063,399,201.48 to \$3,063,419,201.48.
